Executive Summary

The 2024 Minority Businesses Economic Impact Report reaffirms what we at NMSDC have long championed: MBEs are vital to our economy and serve as engines of innovation, resilience, and generational wealth.

With nearly \$600 billion in total production, over 2.2 million jobs supported, and \$168 billion in wages earned, NMSDC-certified MBEs continue to drive prosperity in historically underserved communities.

This year's report highlights strong momentum across the MBE network, with notable growth among Black, Native American, and women-owned businesses.

Now is the time to act. Together, we can build an inclusive economy that reflects America's diverse entrepreneurial talent.

Empowering Economic Impact: Progress, Pressure, and the Path Forward

The National Minority Supplier Development Council (NMSDC) proudly reports that in 2024, NMSDC-certified Minority Business Enterprises (MBEs) contributed \$599.7 billion in total production to the U.S. economy, supported over 2.2 million jobs directly and indirectly by NMSDC-certified MBEs, and generated over \$168 billion in wages earned through supported jobs. These figures confirm what our community has long known: MBEs are not just suppliers—they are anchors of economic strength, innovation, and resilience.

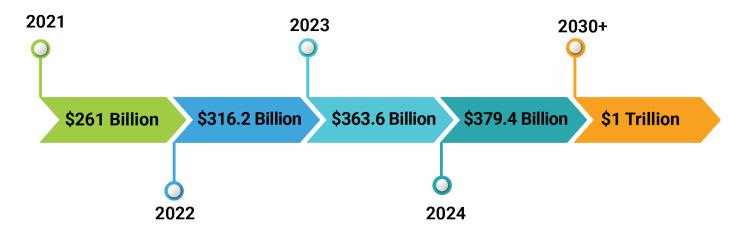






Compared to 2023, this year's numbers reflect meaningful progress—an almost 10% growth in output and a steady increase in jobs and wages. Revenue growth was strongest among Black- and Native American-owned firms, with double-digit increases in income and employment.

Women-owned MBEs also made substantial strides, reinforcing the critical intersection of gender and racial equity in entrepreneurship. Yet, this progress unfolded amidst a changing national landscape. By mid-2024, shifts in policy priorities and public discourse led to a reduced emphasis on diversity-related initiatives across the private and public sectors. As a result, some corporate partners and NMSDC member organizations began scaling back their supplier diversity commitments, contributing to increased uncertainty for NMSDC-certified MBEs. These businesses encountered a tightening of contract opportunities and continued challenges in accessing capital. Reflecting these headwinds, the year-over-year revenue growth of NMSDC-certified MBEs slowed to 4.46%—a marked deceleration from previous double-digit gains.



New MBEs that joined the NMSDC network last year had lower average revenues than those who joined in previous years. In contrast, businesses that chose not to renew their certification in 2024 reported higher average revenues than in the prior period.

Although last year included a greater share of smaller MBEs entering the network, resulting in lower average revenue growth, the Bureau of Economic Analysis reported that the U.S. economy grew by only 2.8% in 2024. This remains far below the growth achieved by NMSDC-certified businesses. These headwinds underscore the urgency for NMSDC to double down on advocacy and innovation to ensure its suppliers continue to outperform the national GDP.

Strategic Priorities Moving Forward

The next few years mark a pivotal time period for the NMSDC network—one that challenges us to not only continue driving economic impact but also to protect the gains we have made over the previous decades. To amplify these gains, we must:

- Scale Capital Access: Deepen partnerships with community development financial institutions (CDFIs), fintech lenders, and impact investors to close persistent funding gaps—especially for Black, Native American, and women-owned NMSDC-certified MBEs.
- **Elevate Tier II Accountability:** Support corporate members to expand MBE inclusion at all levels of their supply chains—Tier II, Tier III, and joint ventures.
- **Expand Our Certification Reach:** As certification becomes centralized at the national office, launch a national digital outreach campaign to certify and activate thousands more MBEs in underserved areas and sectors.
- **Enhance MBE Collaboration:** Facilitate intra-MBE partnerships, financing opportunities, and digital platforms that make collaboration easier and more effective.
- Foster Additional Strategic Alliances: Engage public-private partners, including the U.S. Chamber of Commerce, local economic development councils, HBCUs, Hispanic Serving Institutions, Tribal governments, and Latino and Asian business networks, to extend reach and amplify shared impact.

Total Economic Impact

NMSDC-certified MBEs create an immediate impact through the employees they hire. However, businesses today are highly integrated, with every business relying on other businesses to create their products and services. As a result, MBEs support jobs at not only their own companies, but also at the other businesses they use while running their operations. These MBE suppliers further employ other businesses, creating a chain of economic activity through the entire supply chain.

In addition, MBE employees generate added economic activity at the businesses in their communities. They spend a part of their earnings on expenses such as groceries, education, healthcare, entertainment, housing, etc. This spending supports jobs at businesses employing professionals like teachers, doctors, contractors, etc.

Combined, these three channels of activity multiply the impact generated by NMSDC-certified MBEs.

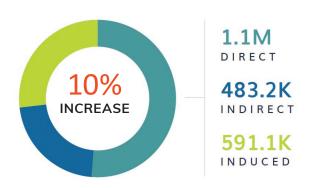
NMSDC-certified MBEs earned \$379.4B in 2024. This revenue resulted in a total impact of \$599.7B on the U.S. economy, with \$106.7B in additional Indirect Impacts, and \$113.6B in Induced Impacts.

NMSDC-certified MBEs hired 1.1M employees. They supported an additional 483.2K jobs at downstream suppliers (Indirect Impact), and 591.1K jobs in their communities (Induced Impact).

Employees at NMSDC-certified MBEs earned \$94.9B in wages. Employees at downstream suppliers earned an additional \$36.3B in wages (Indirect Impact), and employees in their communities earned \$36.9B in wages (Induced Impact).

Economic Impact by Region

NMSDC's regional affiliates serve as the strategic engines of our national network — empowering MBEs to compete, grow, and scale. They translate our mission into measurable impact, connecting contract-ready MBEs with corporate, government, and capital opportunities that drive economic equity in communities across America.

Last year was the first time that NMSDC analyzed the economic impact for each of its regional affiliates, so now we can report year-over-year progress in the charts below.

Driving Economic Growth Through Job Creation

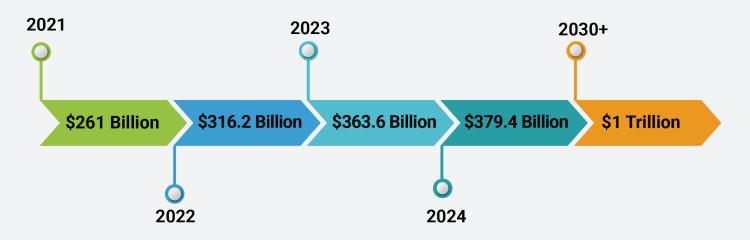

Job Creation by Ethnicity

Overall, we continue to see strong and steady growth across every ethnic minority group that NMSDC serves, reinforcing the strength and resilience of our national network. We saw double-digit growth among Black-owned businesses across revenues, jobs, and wages for the second consecutive year, evidence that our concerted efforts to close long-standing disparities and expand access to contracting and capital are delivering measurable results.

Equally encouraging, Native American-owned firms achieved double-digit gains in revenue and job creation, reflecting the impact of new outreach and engagement strategies that showcased the value of the NMSDC network to tribal and Indigenous entrepreneurs.

Asian Indian-owned MBEs posted strong year-over-year increases in both revenues and employment, demonstrating exceptional leadership in technology, professional services, and manufacturing sectors that continue to drive innovation and global competitiveness.

Asian Pacific-owned firms recorded meaningful growth in revenues, jobs, and wages, underscoring their expanding influence in energy, logistics, and green industries and their ability to connect U.S. supply chains to international opportunities.

Hispanic-owned MBEs maintained their status as one of the fastest-growing segments in the economy, showing solid expansion in revenue and workforce size, particularly in construction, food services, and transportation. Their entrepreneurial vitality continues to be a major force for job creation and economic advancement in communities across the country.

These headwinds underscore the urgency for NMSDC to double down on advocacy and innovation to ensure our suppliers continue to outperform national GDP.

Job Creation at Women-Owned Firms

NMSDC-certified MWBEs make an immediate and direct impact in their communities by hiring employees at their firms to operate their businesses.

Overall, total MWBEs and total revenues are up compared to the previous period, but U.S. jobs and wages are down. This inverse relationship may be largely due to the industry that MWBEs are in. Wholesale trade and professional, scientific, and technical services are among MWBEs' top industries. It's common to see impacts from outsourcing, automation, and technological advancements in these industries. These changes often lead to greater operational efficiency, where fewer employees can produce more output.

As a result, even when revenues rise, it does not necessarily translate into a proportional increase in employment and income. Revenue growth alone does not guarantee broader labor market benefits, especially in industries that are becoming more capital- and technology-intensive.

Regarding Black women-owned businesses, we observed a 1% increase in the MBE count, but no change in their share of revenues. This highlights the continued need for deeper understanding and targeted efforts to address these disparities.

Top Industries by Jobs and Revenue

Profit margins and job creation vary widely from industry to industry. This is especially true as artificial intelligence and other technological advances create new, innovative industries that are prime for greater MBE engagement. Understanding MBE representation across these sectors, both old and new, is key to developing actionable policies and programming that increase their success.

The data, outlined in the charts below, helps inform NMSDC-certified MBEs in understanding emerging industries where they can pivot to or expand into, in order to capitalize on continued growth without being left behind in a declining industry.



Top Industries for NMSDC-certified MBEs*

Although Manufacturing held on to the top industry for NMSDC-certified MBEs, it was the industry out of the top five that grew the least over the last period, only growing by half of a percent in revenue. The two industries that grew the most were Professional, Scientific, and Technical Services, which grew by nearly 13% in revenue, and Construction, which grew jobs by over 28%.



Top Industries by Jobs and Revenue Asian Indian NMSDC-certified MBEs

In 2024, Manufacturing continued its growth from the previous year and surpassed Administrative and Support and Waste Management and Remediation Services to secure the number two industry for Asian Indian NMSDC-certified MBEs.

Additionally, Other Services (except Public Administration) saw the most overall growth with over 20% growth in revenue and over 25% growth in jobs.

The two industries that shrank significantly over the last period were Construction with a 17% decline in revenue, and Retail Trade with a 27% reduction in jobs.







Top Industries by Jobs and Revenue Asian Pacific NMSDC-certified MBEs

In 2024, Wholesale Trade surpassed Manufacturing to take the top industry spot for Asian Pacific NMSDC-certified MBEs, while Professional, Scientific, and Technical Services moved into the third spot, surpassing Finance and Insurance. Additionally, Real Estate and Rental and Leasing knocked Health Care and Social Assistance out of the top ten this year.

The two industries that grew the most were Construction, which grew by over 17% in revenue, and Finance and Insurance, which grew jobs by over 86%. The industry that shrank significantly over the last period was Retail Trade with a 25% decline in revenue and a 14% reduction in jobs.







Top Industries by Jobs and Revenue Black NMSDC-certified MBEs

In 2024, Construction grew over \$2B (almost a 37% increase) to capture the third top industry for Black NMSDC-certified MBEs, pushing down Administrative and Support and Waste Management and Remediation Services as well as Wholesale Trade.

The Information industry also grew significantly, but by way of increasing jobs by over 65%.

Wholesale Trade and Retail Trade saw little to no growth in revenue and Manufacturing saw the largest decline in jobs of over 8%.







Top Industries by Jobs and Revenue Hispanic NMSDC-certified MBEs

In 2024, the two industries that grew the most were Information, which grew by over 20% in revenue, and Construction, which grew jobs by over 20%.

The industry that shrank significantly over the last period was Utilities with a 54% decline in both revenue jobs.







Top Industries by Jobs and Revenue Native American NMSDC-certified MBEs

In 2024, Administrative and Support and Waste Management and Remediation Services jumped two spots to claim the number one industry for Native American NMSDC-certified MBEs with over 164% growth in revenue and 118% increase in jobs.

The industries that shrank significantly over the last period were Transportation and Warehousing with a 60% decline in revenue and a 68% reduction in jobs, followed by Manufacturing with a 13% decline in revenue and a 32% reduction in jobs.







Appendix

Regional and State Breakdown

Ensuring equitable opportunities for NMSDC-certified MBEs to participate in the business ecosystem is critical in moving our nation forward. To understand how and where NMSDC should focus its attention, we must examine our impact at the regional and state level.

By identifying which regions and states are showing positive growth for NMSDC-certified MBE revenue, jobs, and wages and which ones aren't, not only can we provide customized support to each regional affiliate, but we can also identify important insights into the unique situations they face to help promote MBE growth across the network.

Additionally, the state level data is key when advocating for policy changes, both at the state and federal levels, to correct disparate impacts that have unintentionally and negatively impacted NMSDC-certified MBEs in the bidding and contracting process.

The following charts further break down the impact of NMSDC at the regional and state level, including the number of MBEs, revenue earned by those MBEs, and the number of jobs that are created and supported by those MBEs.

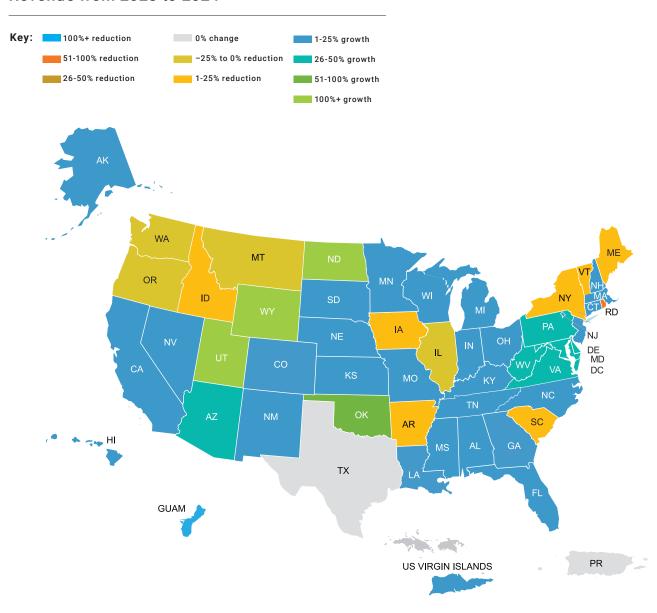
Count and Revenue for NMSDC-certified MBEs by State and Territory

The 2023–2024 data reveal steady national progress with strong regional gains among NMSDC-certified MBEs. States across the Mid-Atlantic, Midwest, and Southwest, including Georgia, Pennsylvania, and Arizona, reported the largest revenue increases among NMSDC-certified MBEs.

Some regions within the Mountain West and Southeast experienced declines, highlighting opportunities to strengthen supplier inclusion commitments and local partnerships.

The following charts breakdown the impact of NMSDC-certified MBEs at the state level, including the number of MBEs, spend with those MBEs, and the number of jobs that are created and supported through the reported spend.

Economic Impact of the Corporate Plus Program

Corporate Plus is a membership program for NMSDC-certified MBEs that have proven their capacity to execute national contracts for major corporations.

NMSDC national corporate members nominate MBEs for this designation, which elevates their profile among national corporate members and facilitates their broader participation throughout the NMSDC network.

We continue to report and monitor the total economic impact of these high-growth MBEs to better understand not only the impact of this unique program on the U.S. economy, but also to begin tracking changes over time to ensure this membership program continues to drive growth.

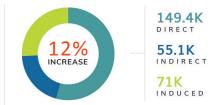
Total economic activity driven through certified Corporate Plus MBEs

NMSDC-certified Corporate Plus MBEs earned \$68.6B in 2024. This revenue resulted in a total impact of \$93.5B on the US economy, with \$11.3B in additional Indirect Impacts, and \$13.6B Induced Impacts.

NMSDC-certified Corporate Plus MBEs hired 149.4K employees. They supported an additional 55.1K jobs at downstream suppliers (Indirect Impact), and 71K jobs in their communities (Induced Impact).

Employees at NMSDC-certified Corporate Plus MBEs earned \$11.9B in wages. Employees at downstream suppliers earned an additional \$4.1B in wages (Indirect Impact), and employees in their communities earned \$4.4B in wages (Induced Impact).

Note: Direct, Indirect, and Induced numbers may not add up to the total due to rounding.

Economic Impact Explained

Economic impact modeling is a standard tool used to quantify the economic contribution of an investment or company. This modeling uses an "Input-Output" economic model to estimate the number of times each dollar of "input," or direct revenues, cycles through the economy in terms of "indirect and induced output," or additional revenues, personal income, and employment.

There are several Input-Output models used by economists to estimate multiplier effects. Supplier. io employed the IMPLAN input-output model in developing estimates of revenues, income, and employment impacts. This model, initially developed by the U.S. Department of Agriculture, examines inter-industry relationships in local, regional, and national economies.

The Input-Output multipliers are derived from a comprehensive and complex set of inputs based on the collection of business and employment data. Indirect impacts of economic activity in a targeted geographic area are calculated by applying multiplier coefficients to the direct impact spending. Since most of the businesses in the study are considered as local businesses, each supplier was assumed to have operations primarily in one state.

These multipliers consider an amount of "leakage" from the state economy because some wages and expenditures will be spent outside of the state.

The economic activity is calculated by state and these state-level results are aggregated to determine the national totals.

Assumptions & Business Rules

This analysis relies on the following assumptions:

- For suppliers that have multiple locations, all impact is evaluated at the headquarters location. This may overestimate the impact in the headquarters state and underestimate the impact in other states.
- For suppliers that provide services in multiple NAICS codes, unless otherwise indicated, all impact is calculated using the supplier's primary NAICS code.

A supplier impact is assumed to be localized within a state.

The model predicts impact results based on industry averages and is an aggregate across all companies. The calculations cannot be applied to individual companies and may differ from actual jobs and incomes at specific companies.

Analysis was performed using the following business rules:

- Initial year end data, pulled in early January 2025, included MBEs that expired in December 2024, under the assumption that a majority to all would complete certification renewal.
- If an MBE was missing revenue data in the most recent year, the previous year's revenue was included in the most recent year's revenue field.
- If an MBE was missing data in both years, had zero revenue in both years, or had negative revenue, these MBEs were removed from the analysis.
- If an MBE had a status of expired, these MBEs were removed from the analysis.

Based on these data analysis rules, NMSDC's 2024 Minority Businesses Economic Impact Report may vary from regional affiliate economic impact reports or otherwise published data from the regional affiliates or NMSDC that may use different business rules during the analysis.
